NOTIFICATION UNDER ARTICLE 12.1(B) OF THE AGREEMENT ON SAFEGUARDS ON FINDING A SERIOUS INJURY OR THREAT THEREOF CAUSED BY INCREASED IMPORTS (EXTENSION OF THE EXISTING MEASURE)

The following notification, dated and received on 11 August 2022, is being circulated at the request of the delegation of Indonesia.

Pursuant to Article 7.2 and Article 12.1(b) of the WTO Agreement on Safeguards, The Government of the Republic of Indonesia, hereby notifies the Committee on Safeguards the investigation findings concerning the extension of a safeguard measure against the importation of Fabrics.

1. Evidence that the safeguard measure continues to be necessary to prevent or remedy serious injury or threat thereof and that the industry concerned is adjusting

The Government of the Republic of Indonesia initiated an investigation on the extension of a safeguard measure on 28 April 2022 (G/SG/N/6/IDN/31/Suppl.1 - G/SG/N/14/IDN/3). The scope of the investigation was to decide whether the safeguard measure should be extended beyond 8 November 2022.

To determine whether the safeguard measure continues to be necessary to prevent or remedy serious injury or threat thereof and whether the industry is adjusting, the Investigating Authority (*Komite Pengamanan Perdagangan Indonesia*/KPPI) undertook a comprehensive analysis of a broad set of data from multiple sources: the evidence provided by the Applicant's member industries in their questionnaire replies and written submissions, the information provided by interested parties (users, importers, exporting producers and exporting country governments) in their written submissions, as well as information available to the Investigating Authority including statistical databases and relevant publications.

1.1. Economic performance of the Applicant

To assess the economic performance of the Applicant, the developments of imports, and, other relevant data included in its assessment, the Investigating Authority assessed the data for the period 2019-2021 ('the investigation period'). The Applicant's performance indicators related to all products concerned in the safeguard investigation are presented in the table below, whereas the indicators related to each product category are given in Annex-I.

During the investigation period 2019-2021, domestic sales experienced a downward trend of 7.15%. Along with the downward trend in domestic sales, the Applicant's production also experienced a downward trend of 7.98%. This is because, in 2021, the Applicant has not been able to increase their production and domestic sales compared to 2019. Meanwhile, the domestic market is still flooded with imported goods.

In 2020, domestic sales decreased significantly by 16.36% compared to 2019, from 100 index points to 83.64 index points. In 2021, domestic sales increased by 3.08% compared to 2020, from 83.64 index points to 86.22 index points in the same period.

Production experienced a significant decline in 2020 by 17.86% compared to 2019, from 100 index points to 82.14 index points. Then in 2021, production continues to increase in line with the increase in national consumption, production is seen to increase by 3.10% compared to 2020, from 82.14 index points to 84.68 index points.

During the investigation period 2019-2021, Applicant's inventory experienced an increasing trend of 2.97%. This is due to the downward trend in domestic sales and production. In 2020, Applicant's inventory increased by 7.96% compared to 2019, from 100 index points to 107.96 index points. Then in 2021, Applicant's inventory decreased by 1.79% compared to 2020, from 107.96 points to 106.03 index points.

The decrease in the volume of production as explained above is a result of a decrease in utilization capacity with a trend of 8.61% during the investigation period 2019-2021. Furthermore, in 2020 the utilization capacity decreased significantly by 18.88% compared to 2019, from 100 index points to 81.12 index points. In 2021 the utilization capacity increase slightly by 2.96% compared to 2020, from 81.12 index points to 83.52 index points.

During the investigation period 2019-2021, the Applicant's employment experienced a decline with a trend of 4.64%. In 2020, employment decreased by 10.00% compared to 2019 from 100 index points to 90.00 index points. In the same year, the Applicant made efficiency efforts by reducing the

number of employees, because the Applicant was still experiencing financial losses. Furthermore, in 2021, the number of employees increased by 1.05% compared to 2020, from 90 index points to 90.94 index points. This is due to an increase in the Applicant's production by 3.10%.

During the investigation period 2019-2021, the productivity of the Applicant experienced a downward trend of 3.50%. This was due to the decline in the trend of production volume by 7.98% which was greater than the decline in the trend of the employee, which was 4.64%. In 2020 the productivity of the applicant has decreased by 8.73% compared to 2019, and in 2021 the productivity of the Applicant has increased by 2.02% compared to 2020.

During the investigation period 2019-2021, domestic sales experienced a downward trend of 7.15%. In 2020 domestic sales decreased by 16.36% compared to 2019 from 100 index points to 83.64 index points. Then, in 2021, domestic sales increased by 3.08% compared to 2020. There was a financial loss in 2020 compared to 2019 as a result of a decline in domestic sales, from a profit of 100 index points to a financial loss of (306.35) index points. Then, in 2021 the loss increased by 38.52% compared to 2020, from (306.35) index points to (424.35) index points. This happened because the Applicant sold their products at prices below production costs due to pressure on the selling prices of imported products. Thus, during the 2019-2021 period, the Applicant experienced an increase in financial losses with a trend of 99.86%

During the 2019-2021 period, national consumption decreased with a trend of 10.47%. In 2020, national consumption decreased significantly by 24.64% compared to 2019, from 100 index points to 75.36 index points. In 2021, national consumption will increase by 6.36% compared to 2020, from 75.36 index points to 80.15 index points.

During the investigation period2019-2021, the import market share experienced a decline with a trend of 12.39%. Although the import market share trend during this period decreased, in 2021 it increased again by 0.75% compared to 2020, from 76.19 index points to 76.76 index points.

During the investigation period 2019-2021, the market share of the Applicant has increased with a trend of 3.72%. Although the trend of the Applicant's market share in that period has increased, in 2021 the Applicant's market share has decreased by 3.08% compared to 2020, from 110.99 index points to 107.57 index points. So we can conclude that the domestic market share was eroded by imported goods in the same year.

The purpose of the extension of the safeguard measure is to fulfill the Applicant's commitment to completing their structural adjustment program as well as recovering the serious injury. Even though the trend of Applicant's market share is increasing, the Applicant is still experiencing serious injury. The extension of the safeguard measure is necessary so that the Applicant can fulfill the commitments to complete the structural adjustment program and improve the performance of their industries.

The Applicant's performance indicators related to all products concerned in the safeguard investigation are presented in the table above, whereas the indicators related to each category are given in Annex-I.

During the investigation period 2019-2021, there was a price undercutting where the selling price per unit of imports was below the selling price per unit of the Applicant. Thus, making it difficult for the Applicant to increase domestic sales and make a profit

During the 2019-2021 period, the production cost per unit of the Applicant increased with a trend of 18.35% along with the increase in production costs per unit of the applicant, in that period. The selling price per unit of the applicant also increased with a trend of 17.73%.

Based on the table above, in 2020 and 2021 price suppression occurred because the production cost per unit of the Applicant is always above the selling price per unit of the Applicant, while the highest margin loss occur in 2021, namely (1.14) index points. This is an attempt by the Applicant to compete with the import price. This causes the Petitioner to continue to suffer serious injury.

1.2. Evidence that the industry concerned is adjusting

The Applicant has fulfilled some of its structural adjustment commitment programs in order to be able to compete with imported goods. However, due to the large presence of imported fabrics in the market, the Applicant was not able to optimally fulfill their structural adjustment programs and, therefore, the recovery of the Applicant's injury was delayed. The realization of the structural adjustment program for each Fabric categories that has been completed by the Applicant is as follows:

As shown in the table above, the import volume of the Subject Good during the investigation period experienced a downward trend of 21.56%. The downward trend in the import volume of the Subject Good during the 2019-2021 period occurred due to the decline in the volume of imports referred to in 2020 by 42.58%. This shows that the imposition of the definitive safeguard measure which has been in effect since 9 November 2019 is very effective. However, in 2021 the import volume of the Subject Good increased by 7.16% compared to 2020 from 249,828 tons to 267,704 tons.

The absolute increased imports of each product category are listed in Annex II.

Based on the table above, imports relative to national production during the 2019-2021 investigation period experienced a downward trend of 14.92%. The downward trend in the imports relative to national production during the 2019-2020 investigation period occurred due to the decline in the volume of imports in 2020 by 42.58% compared to the previous year, as a result of the effective imposition of the definitive safeguard measure which has been in effect since 9 November 2019. However, in 2021 the imports relative to national production increased by 2.74% compared to 2020 from 70.45 index points to 72.38 index points.

The relative increases in imports to the national production of each product category are listed in Annex II.

Based on Minister of Finance Decree No. 34/PMK.010/22, there is 1 HS number in BTKI 2017 namely HS 5407.10.29 that has changes to HS number Ex.5407.10.20 in BTKI 2022 with a description of woven fabric bleached, obtained from high-strength yarns of nylon or other polyamides, or of polyesters for tires; conveyor duct.

The product categories and 107 8-digit HS that are subject to the proposed safeguard measure are listed in Annex-III.

5. Description of the proposed measure

The proposed measure is in the form of a specific tariff available for each HS code under BTKI 2022.

The proposed extension of the safeguard measure will come into effect on 9 November 2022.

The expected duration of the proposed extension of the safeguard measure is three years, until 8 November 2025.

11.1. Evidence that the industry concerned is adjusting and that the safeguard measure continues to be necessary to prevent or remedy serious injury.

Although the definitive safeguard measure has been imposed on the Subject Good, the fact is that the imports are still increasing both in absolute and relative terms in 2021 and the volume of imports will increase significantly if the safeguard measure is not extended.

In addition, the Applicant's performance data shows a serious injury as evidenced by a downward trend in several performance indicators of the Applicant, such as production, domestic sales, productivity, utilization capacity, and employment, as well as an increase in inventories and financial

losses. If the safeguard measure is not extended, the Applicant's serious injury will continue to occur and may even lead to bankruptcy. There is a causal link between the serious injury suffered by the Applicant as a result of the increase in the number of imports of the Subject Good and not caused by other factors.

The Applicant has completed some of the structural adjustment programs, however, the Applicant still needs additional time to complete the programs. If the safeguard measure is not extended, the Applicant will not be able to complete the structural adjustment program and will be difficult in competing with imported goods.

11.2. Reference to the WTO document that notified the initial application of the measure.

Pursuant to Article 12.4 of the WTO Agreement on Safeguards, on 13 November 2019, The Government of the Republic of Indonesia notified the Committee on Safeguards regarding the imposition of a provisional safeguard measure on the imports of Fabrics on 9 November 2019 (G/SG/N/7/IDN/2/Suppl.1 - G/SG/N/11/IDN/18/Suppl.1).

Pursuant to Article 12.1(c) of the WTO Agreement on Safeguards, on 3 June 2020 The Government of the Republic of Indonesia notified the Committee on Safeguards regarding the decision to impose a safeguard measure on the imports of Fabrics on 27 May 2020 (G/SG/N/10/IDN/23/Suppl.1 - G/SG/N/11/IDN/18/Suppl.2).

11.3. Duration of the measure from initial application till the date at which it will be extended

The duration of the provisional safeguard measure was 200 days from 9 November 2019 until 26 May 2020 and the initial definitive safeguard measure was imposed from 27 May 2020 until 8 November 2022. The extension of the safeguard measure is proposed to be imposed for 3 years, until 8 November 2025.

11.4. Precise description of the measure in place prior to the date of extension

The latest version of the measure in place can be found in Indonesia's notification of 19 July 2021 (G/SG/N/11/IDN/18/Suppl.3). The original measure was notified on 3 June 2020 (G/SG/N/10/IDN/23/Suppl.1 - G/SG/N/11/IDN/18/Suppl.2).
