The following notification, dated and received on 29 May 2026, is being circulated at the request of the delegation of Indonesia.

Pursuant to Article 7.2 and Article 12.1(c) of the WTO Agreement on Safeguards, the Government of the Republic of Indonesia hereby notifies the issuance of Minister of Finance's Decree Number 36 of Year 2026 dated 21 May 2026, promulgated in the Official Gazette of the Republic of Indonesia Year 2026 Number 329 on 2026 regarding the extension of the imposition of a safeguard measures on the importation of "Curtains (including drapes), interior blinds, bed valances, and other furnishing articles", for a period of 2 (two) years starting on 22 May 2026. A. General background

On 5 March 2026 the Republic of Indonesia notified the findings of investigation in which it was concluded that the relevant safeguard measure needs to be extended, in particular, to remedy serious injury suffered by the Applicant. The extension of such safeguard measures will also give the Applicant the opportunity to continue their adjustment program in order to improve the competitiveness of domestic industry ([G/SG/N/8/IDN/24/Suppl.3](#)-[G/SG/N/10/IDN/24/Suppl.4](#)).

It was also indicated in the notification that the Investigating Authority was proposing to the Government of the Republic of Indonesia, to extend the imposition of a safeguard measures duty on the importation of the Subject Goods in the form of specific safeguard duty.

B. Subject good

Curtains (including drapes), interior blinds, bed valances, and other furnishing articles, under Harmonized System (HS.) codes based on Indonesian Custom Tariffs Book (BTKI) Year 2022 are: 6303.12.00, 6303.19.90, 6303.91.00, 6303.92.00, 6303.99.00, 6304.19.90, 6304.91.90, and 6304.92.00.

C. Description of the safeguard measure

1. With reference to the proposal from the Investigating Authority, and taking into account the need to effectuate the safeguard measure as proposed and the relevant requirement stipulated in the WTO Agreement on Safeguards, the Government of the Republic of Indonesia has decided to impose the following safeguard duty:

Timetable of the safeguard duty

Period	Safeguard duty
1 st year (22 May 2026 – 21 May 2027)	Rp. 9,841/Kg
2 nd year (22 May 2027 – 21 May 2028)	Rp. 9,248/Kg

2. According to Article 9.1 of the WTO Agreement on Safeguards, developing country Members with less than 3% import share collectively account for not more than 9% of total imports of the subject goods are excluded from the safeguard measures. Hence, the collective percentage of developing country Members below 3% reaches 13.29% from the total import of the subject good as stated on the notification [G/SG/N/8/IDN/24/Suppl.3-G/SG/N/10/IDN/24/Suppl.4](#), therefore there is no exclusion on developing countries Members.
